## Puppy Socialization & Training Class Application

Socialization, training, and owner education are important for every dog, but are even more critical in the development of a German Shepherd Dog. That is why the German Shepherd Dog Club of Minneapolis and St. Paul offers socialization & obedience training classes to teach you how to train your dog. A key benefit to this class is that the owners are surrounded by other GSD owners as we discuss GSD issues and solutions.

The puppy Socialization & Training class is designed for puppies between 2 and 6 months of age. Core components of this class are: controlled socialization, collar and clicker training, positive reinforcements/treats, learning about the different imprinting stages of a puppy/dog as it ages, preliminary obedience, and how to address housebreaking, nipping, chewing and barking problems. Each week the dogs are involved in structured socialization and are introduced to new and unique stimuli to help work on the "Rule of 7".

The class comprises a block of 10 weekly 45-minute sessions with an orientation session the first week that does not include your dog. The non-refundable cost of the 10-week course is \$90 for GSDCMSP club members; \$110 for non-members.

# STUDENT AGREEMENT

I assume full responsibility for myself, my dog, and my family members who accompany me. I further agree to hold **THE GERMAN SHEPHERD DOG CLUB OF MINNEAPOLIS AND ST. PAUL** and **THE ANIMAL INN TRAINING CENTER, INC.**, their agents, instructors, or employees faultless for any injury or loss I may occur to myself, my dog or any dog in my care. I will also abide by the stated rules and will insure the same of my companions. The following is an excerpt from the standing rules of **THE GERMAN SHEPHERD DOG CLUB OF MINNEAPOLIS AND ST. PAUL**.

## D. TRAINING-CHILDREN AS HANDLERS

1. Children under fifteen (15) years of age may train only under their parent's or guardian's presence at the training facility. The Director of Training determines the child's ability to handle the dog in class.

## E. TRAINING CLASS RULES

1. Dogs deemed unmanageable by the instructor must be removed from the class promptly and should be brought to the attention of the Director of Training for prompt action.
2. Handlers may enter or leave class only with permission of the instructor.
3. Smoking in the training center is not permitted.
4. It is recommended that a training collar and leather leash, six (6) feet long be used for training.

## RULES FOR DOGS ON THE PREMISES

1. Dogs must be kept on leash at all times when at the training facility, except when in the ring doing advanced exercises requiring no leash.
2. Dogs are not to be tied unattended anywhere in the training facility.
3. Females in season are not allowed in the training facility.
4. If a dog has relieved itself in the training facility or on the outside grounds, the handler must promptly clean up after their dog. A shovel and place of disposal are provided. Each handler is responsible to clean up after his own dog(s).
5. Dogs are to be exercised in the designated areas only.
6. There shall be no unauthorized use of training equipment.
7. All dogs brought to the training facility must show proof of current (temporary or permanent) shots for immunization against distemper, infectious hepatitis, rabies and parvovirus on demand.
