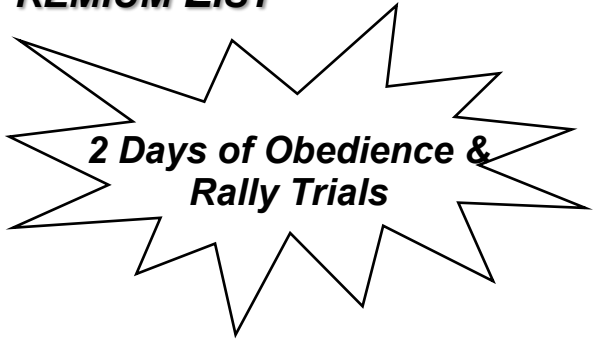

EXHIBITORS . . . PLEASE NOTE

ENTRY FEES MUST ACCOMPANY ENTRIES. CONDITIONAL, UNSIGNED, INCOMPLETE, OR TELEPHONE entries cannot be accepted. ENTRIES NOT ON OFFICIAL AKC ENTRY FORMS or photocopies of entry forms without the agreement and rules on the reverse side of the Official AKC entry form are NOT ACCEPTABLE.

THE CLUB AND ITS SHOW SECRETARY ASSUMES NO RESPONSIBILITY for wrong or incomplete information given on the entry blank by the owner or agent of the owner. This Club and its Show Secretary assume no responsibility for the owner or owner's agent entering a dog twice or in a class for which the dog is ineligible to compete.

CONFIRMATION OF ENTRY & JUDGING SCHEDULE will be sent to the address/email on the Official AKC entry form after the closing date. If an exhibitor has not received a copy of the Judging Schedule within seven days of the show date, the Show Secretary should be contacted.

The GSDC of MSP may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness, or other causes and no one shall have any claim or recourse against the Host Club or any official thereof.

NOTE . . . Foreign dogs are eligible for Puppy Classes and Open Classes, effective January 1, 1985.

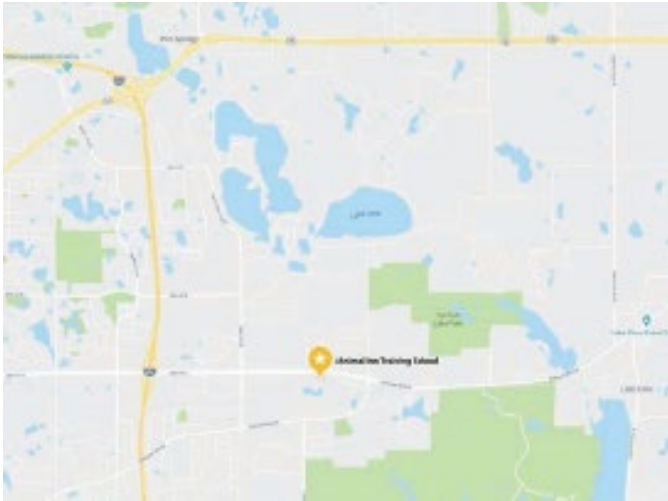

Ring Procedures—New for COVID-19 Compliance

General procedures for both Obedience and Rally. Handlers will check themselves in and pull their armbands and rubber bands. Judges will not hand out ribbons, you will have to pick up your own, just like agility.

Obedience:

Novice—no posts for figure 8, big cones instead. Leash can be “tossed” to steward or handed to the Judge who will put it on the go get it chair. Stays will be the same as regulation. Judge will sanitize between dogs, (this is due to the requirement that the judge touch the dog on the stand/stay ex.)

Open—Figure 8 the same as Novice. Handler will leave their Dumbbell on a chair just outside the ring and recover it themselves. Stewards changing jumps will be assigned to a jump for the entire class and will sanitize before and after each class. Handler will deposit their leash on the go get it chair and later will go get it. Steward will then wipe each leash chair. Handler will pick up DB on the way out of the ring. DB Chair will be wiped before the next DB is placed on it.

Utility—For articles, we will use a plastic tub container. Handler will place articles in the tub with gloves on top prior to entering the ring. Glove steward will use tongs or rubber gloves to handle gloves, (there will be a lot of tong use in this class). If gloves are used by Steward, Steward will sanitize between exhibitors. Article Steward will select the in-use articles and place them on the in-ring chair using tongs. When the article ex comes up, article Steward will place the pile using tongs. Judge will take the article on the clipboard, as usual and place in the pile. After the exercise is completed, article Steward will recover the articles with tongs. Judge will sanitize between dogs for the moving stand ex. As with Open, Stewards will be assigned jumps to change

Rally:

Walk throughs will be limited in both number and time. Details to be determined by entry. Exhibitors, please practice doing walk throughs so you can cut the number of times you need to walk a course before you feel comfortable working it. Leash runner in Masters and Advanced will wear gloves.

Covid-19 Social Distancing Plan for GSDCMSP Obedience/Rally Trials

1. **WHEN TO STAY HOME** - If you feel unwell, have a fever, cough, or sneezing before leaving for the show, please stay home. If you have recently been in the presence of a person who has either tested positive for COVID-19 or has the symptoms noted above, stay home. You can text the event secretary if you are unable to attend. Anyone who attends a public gathering must recognize they will always be at a risk that they could contract Covid-19 despite all the precautions that will be taken to reduce that risk.
2. **OBEDIENCE EVENTS & RALLY EVENTS** - There will be 2 Obedience and 2 Rally trials each day. Each class will be judged once, at a time yet to be determined. If you are only entered in the Obedience Trial or the Rally Trial, you will be expected to leave the show grounds following the awards for the class in which you are entered. If you are entered in both Trials, you will be expected to leave the show grounds upon completion of the awards for the Trial #2 class in which you are entered.
3. **NO SPECTATORS** will be permitted at these trials or on the show grounds.
4. **NO CHILDREN** under 13 will be permitted at these trials or on the show grounds unless showing a dog.
5. **INDOOR CRATING** – There will be no indoor crating, except for judges and stewards.
6. **PARKING** – If you own or can secure a tent or easy-up type shelter, you are encouraged to bring it for outdoor seating. This will be in the parking lot so bring weights and lines to secure it down in case of wind. Please maintain social distance of at least six feet at all times when going to and from your car with or without your dog.
7. **DOG EXERCISE AREA** – As always, pick up after your dog and dispose in can in the exercise area, or pack it out with you. Maintain at least the required six feet of distance while you are exercising/warming up your dog outside the building and in the potty area. Dogs must be on leash. Give space to those exhibitors preparing to enter the building to compete.
8. **CHECK IN TABLE** - There will be a Check In table inside the main entrance of Animal Inn building. (Check in table may be outdoors if weather permits). Please check in without your dog. Stay behind the tape line to maintain the six-foot distance from check in steward. If there is a line, maintain at least six feet between you and the next person. When asked, give your armband number and class(es) and we will give you an armband.
9. **ARRIVAL TIME** – No check in earlier than 60 minutes before the start of your class. You may be on site, but only indoors to set up a crate, or attend to your dog returning outside to lessen the number of people inside to state required limits.
10. **HAND HYGIENE** - There will be a sanitizing station as you enter the building. Sanitize your hands before approaching the check in table, and again before opening the door to exit the building. Sanitizer will be located at multiple locations throughout Animal Inn.
11. **CLASS STAGING** - For each class, a steward will monitor when you may move to the Obedience or Rally rings. This steward will call your arm band number two dogs before you are due in the ring. The Steward will give you a route to follow. The ring steward will call each dog ringside in catalog order. Be sure to remain at least six feet from the steward's table, the ring entry, and the dog leaving. After competing remove your dog from the ring & follow the steward's direction for the route to return to the crating area. Maintain at least six feet between you, other exhibitors and anyone else at all times.
12. **PERSONAL CHAIRS** - Under the current plan, there will be no chairs at ringside.
13. **JUDGES and STEWARDS** - will maintain social distance as practical in and around the ring between each other, exhibitors and spectators. Hand sanitizer or washing supplies will be near the ring entry along with Kleenex and a bag for disposing of same.
14. **FACE MASKS** – will be required of everyone at all times while in and around Animal Inn. Bandanas will be permitted in addition to masks. Either must cover your nose, mouth, and chin to protect others. At their discretion, the Judge may choose to wear a face mask while in the ring or not as long as they maintain minimum 10' social distancing. Exhibitors do not have to wear mask while showing. Stewards and other officials will also wear facemasks, and gloves as needed. Cones will be used for figure

8 exercises. Judges will design procedures that minimize handling of items. Exhibitors may wish to familiarize dogs to that 'look' before the event.

15. CLASS AWARDS - At the conclusion of each class, judge will call qualifiers into the ring. Maintain a minimum of six feet between you and other individuals in the ring. Your dog need not be present for this ceremony. Ribbons will be placed on a table outside the ring and exhibitor can pick up on their way past the table.
16. LUNCH - will be on your own for all exhibitors. Judges, stewards, and committee members will be served commercially packaged box lunches to eat in their vehicles or Hospitality area. Handlers who wish food for themselves or their dogs must bring it with them and clean up afterwards.
17. PHOTOGRAPHER and VENDORS – Neither will be at these trials.
18. PERIODIC CLEANING - Door handles and common surfaces will be wiped down at lunch break and after closing on each day. Exhibitors are encouraged to access after using hand sanitizers and to wipe down at other times.
19. TRIAL CANCELLATION – German Shepherd Dog Club of MSP reserves the right to cancel this trial at any time. Should that happen, any checks for trial entry fees will be shredded.
20. PLAN UPDATES – Will be made as needed should the State of Minnesota and /or the AKC require any changes. Update to this plan will be sent to exhibitors with the judging program. Thank you for your cooperation and patience.
