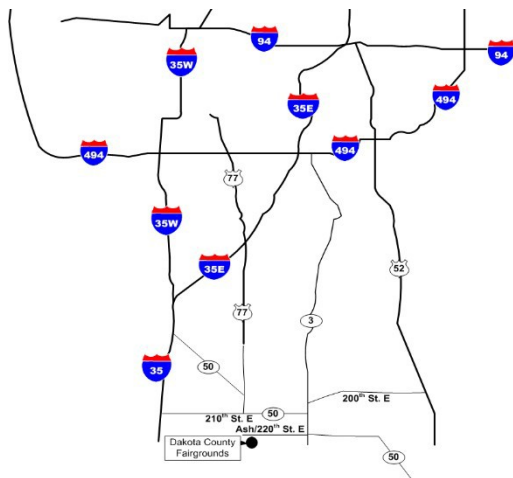


## DIRECTIONS TO SHOW SITE

If because of riot, civil disturbances, or other acts beyond the control of the management it is impossible to open or complete the show, no refund of entry fee(s) will be made.

THE CLUB AND ITS SHOW SECRETARY ASSUMES NO RESPONSIBILITY for wrong or incomplete information given on the entry blank by the owner or agent of the owner. This Club and its Show Secretary assume no responsibility for the owner or owner's agent entering a dog twice or in a class for which the dog is ineligible to compete.

CONFIRMATION OF ENTRY & JUDGING SCHEDULE will be sent to the address/email on the Official AKC entry form after the closing date. If an exhibitor has not received a copy of the Judging Schedule within seven days of the show date, the Show Secretary should be contacted.

RETURNED CHECKS do not constitute a valid entry fee. The Club will add a collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitor may result in their being put on a CASH ONLY basis.

Exhibitors & Handlers will be responsible for clean conditions in & around their crates.

Dogs need not be at show until scheduled time of judging. Dogs will be excused following the judging of their class unless needed for further judging.

### JUDGES WILL NOT WAIT FOR ANY DOG HOLDING UP A CLASS.

ALL PRIZES WILL BE AWARDED IN THE RING. The Club reserves the right to substitute any trophy with one of greater or equal value if conditions make it necessary. NO TROPHIES will be mailed.

The GSDC of MSP may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness, or other causes and no one shall have any claim or recourse against the Host Club or any official thereof.

NOTE . . . Foreign dogs are eligible for Puppy Classes and Open Classes, effective January 1, 1985.

The welfare of the exhibitor's child is the responsibility of the exhibitor. It is expressly understood that exhibitors will exercise control and restraint over their children on the day of the Show.
