You must pass two temperament tests, under two different judges to receive your AKC Temperament title. This is a non-competitive event. You do not have to

pre-qualify.

There will NOT be a judge's briefing before each test to avoid close contact and too many people congregating in one area.

Conditions of Entry

AKC COVID-19 EVENT WAIVER must be signed at time of entry.

Incomplete entries or forms without signature will not be accepted. Temperament tests are open to all dogs at least 12 months of age that are individually registered with AKC, recorded in the Foundation Sock Service (FSS) program, individually registered with a foreign or domestic registry organization whose pedigrees are acceptable for AKC registration, dogs granted a Purebred Alternative Listing (PAL) number, dogs with AKC Limited or Conditional Registration, or dogs enrolled in the AKC Canine Partners program. Dogs with breed disqualifications and monorchid/cryptorchid dogs are eligible to participate.

German Shepherd Dog Club of MSP will be following Federal, State, Local, and AKC suggested guidelines to keep workers and ATT participants safe.

Please follow these guidelines:

- Always maintain social distancing
- Do not congregate around the secretary's table
- Everyone needs to wear a mask within 20 feet of the testing building
- You must wear a mask during testing. All helpers will wear masks.
- Avoid touching dogs that are not your responsibility
- Hand sanitizer will be available.

Please read:

- Dogs may NOT wear prong collars, e-collars, head collars or harnesses that restrict movement during the test.
- Dogs may wear slip collars on dead ring, buckle collars, martingales or body harnesses.
- The use of food is not permitted.
- The use of clickers is not permitted.
- The use of toys as rewards is not permitted.
- You may talk to your dog, but no verbal or leash corrections.
- No luring of dog (no use of imaginary food).
- Entered dogs will not be permitted into the building until their testing time.
- There will be NO crating area inside for the dogs.
- There will be a holding area for the next 3 exhibitors. Only the dog and handler may be in this area. All other participants must wait at least 20 feet from the test area.
- Soiling the test area is an automatic dismissal.
- There is no room for spectators.

Test Modification – these modifications are in effect until December 31, 2020
ATT ITEM AS IT IS CURRENTLY WRITTEN AND MODIFICATION FOR COVID-19

Evaluator approaches, greets handler

MODIFY: Handler/Evaluator pretend handshake or elbow bump

Auditory items—steward within 3 ft

MODIFY: Adjust distance to 6 ft.

Visual items—3-5 ft. from steward

MODIFY: Adjust distance to 6 ft.

Unexpected stimuli – within 5 ft. MODIFY: Adjust distance to 6 ft
