President's Report (Peggy Simerson):

 - GSD Fun Day Great event, good attendance. A few things to think about for next year:
 - Discuss shifting this event to later in the year when the weather is cooler (fall)
 - Need to get more people involved in the planning
 - Would like to be able to offer something to sell to help cover costs.
 - Did have a few issues with parking (due to good attendance) but need to do more directing for traffic to keep it to the correct areas for future events.
- State Fair Demo Day Sunday, Sept. 6:
 - o Peggy distributed some tickets/parking passes; however noted that there is a finite amount of parking passes and encouraged people to carpool.
 - Cindy moved that we pay to cover the additional tickets for members; Jinny seconded; motioned carried.
 - Wear your t-shirts Peggy is working with Bo to get a list of people with sizes. Bobby has designed a Fair T-Shirt we could give participants a t-shirt. Keep off the year maybe? Cindy moved to approve \$1,000 cap to provide t-shirts to member participants. Eileen seconded the motion. Motioned carried.

Vice President's Report (Eileen Varhalla):

• Eileen was at the Kathy DuVall's FaerieLand Rescue over the weekend to do some work and clean-up, the next work day is on Aug. 30. All are invited and help is so appreciated.

Secretary's Report (Sarah Falk):

- Sarah reported eight contacts since our last meeting (about two a week), various question types.
- Facebook hits are up to 369 likes (increase of 7.0% or 23 likes).

Treasurer's Report (Diane Blasius Brown):

- Checking: Beginning Balance is \$23,450.37 Ending Balance is \$33,312.35
- Money Market: Balance \$10,755.90 (earned \$1.24)
- Switching banks to Wells Fargo and moving funds from money market into a higher-yield savings account with a higher return of .5%. No fee checking account. Third account is for credit card account that has 2.5-3% per transaction and a \$15 monthly fee.
 - Our data relationship would be 100% with First Data rather than the bank. Diane recommends we test the online payment option with upcoming membership renewals. Sarah pointed out that this would be an option that would be available for online payment; however those who wished to send a check by mail would still be able to renew via the current process (mail). Diane then reiterated this isn't meant to be a replacement for the
