### **Clipping Nails**

Trimming your dog's nails is not just a part of grooming, but is important for your dog's health as well. It is important to remember that untrimmed nails can cause a variety of problems including broken nails that are painful and bleed profusely. In some cases, nails will actually curl and grow back into the dog's feet.

A good indication that dogs' nails are too long is a telltale 'click-click' when walking on uncarpeted areas.

How many of us put off trimming our dog's nails until the inevitable veterinary check-up comes around and the veterinarian must do it? If you are like many dog owners, you may be hesitant to trim your dog's nails because you are afraid of cutting the quick of the nail, which may cause pain or bleeding. Once you learn how to do it, clipping your dog's nails is almost as easy as clipping your own.

When you are trimming your dog's nails, you are only cutting away the excess. Recognizing what is excess and where the nerves and blood vessels begin is what you need to know to make nail trimming a painless process for both you and your dog. To trim your dog's nails:

1. Assemble what you will need - a high quality pair of trimmers and some styptic powder, Kwik-Stop, CutStop Styptic Pads or other product to stop bleeding if you nick the quick.

2. You may want to sit on the floor with your dog, hold your dog in your lap, or have someone hold your dog on a table. Hold your dog's paw firmly and push on his pads to extend the nail. Locate where the quick ends. With clear or light nails, it is easy to see the pink color where the quick ends.

3. Using a nail trimmer for dogs, cut the nail below the quick on a 45-degree angle, with the cutting end of the nail clipper toward the end of the nail. You will be cutting off the finer point. In dogs, especially those with dark nails, make several small nips with the clippers instead of one larger one. Trim very thin slices off the end of the nail until you see a black dot appear towards the center of the nail when you look at it head on. This is the start of the quick that you want to avoid. The good news is that, the more diligent you are about trimming, the more the quick will regress into the nail, allowing you to cut shorter each time.

4. In some cases, if the nails are brittle, the cut may tend to splinter the nail. In these cases, file the nail in a sweeping motion starting from the back of the nail and following the curve to the tip. Several strokes will remove any burrs and leave the nail smooth.

5. If your dog will tolerate it, do all four feet this way. If he will not, take a break. And do not forget the dewclaws. On most breeds, if they have not been removed, dewclaws are 1-4" above the feet on the inner side of the legs. If not trimmed, dewclaws can grow so long they curl up and grow into the soft tissue, like a painful ingrown toe nail.

6. If you accidentally cut the quick, wipe off the blood and apply Kwik-Stop or styptic powder to stop the bleeding. It is not serious and will heal in a very short time.

Some valuable tips:

• Remember, it is better to trim a small amount on a regular basis than to try and remove large portions. Try to trim your dog's nails weekly, even if long walks keep them naturally short. The 'quick,' a blood vessel that runs down the middle of your dog's nail, grows as the nail grows, so if you wait a long time between cuttings, the quick will be closer to the end of the nail. This means more likelihood of bleeding during trimming.

• Trim nails so that when the dog steps down, nails do not touch the floor.

• Invest in a good pair of nail trimmers in an appropriate size for your dog. They can last a lifetime.

• Make trimming time fun and not a struggle. Trimming your dog's nails does not have to be a chore or unpleasant. If your dog is not used to having his nails trimmed, start slowly, and gradually work up to simply holding his toes firmly for 15-30 seconds. Do not let him mouth or bite at you. It can take daily handling for a week or more to get some dogs used to this. When your dog tolerates having his feet held, clip just one nail, and if he is good, praise him and give him a tiny treat. Wait, and then at another time, do another nail. Continue until all nails have been trimmed. Slowly, you will be able to cut several nails in one sitting, and finally all the nails in one session.

### What is a Match and What do I Enter? by Julie Swinland

Periodically throughout the year our club holds a santioned match. According to the AKC :"A Sanctioned Match is an informal event at which neither Championship points nor credit toward an Agility, Rally, or Obedience Title are awarded. They are events at which dog clubs, judges, stewards, and exhibitors and their dogs gain experience needed for licensed events". Matches are much less expensive than actual shows and you enter the day of the match.

Our club offers three types of classes, in our matches; conformation, obedience, and rally. These may seem self-explanatory to those who have been showing for years, but for those not born with a 12 foot leash sprouting out of their hand, or rally signs coming out their ears, they may be confusing.

**Conformation:** In this class the judge is looking at how the dog is put together and how he/she moves. A dog that is correctly put together according to the standard\*, should move well with the typical German Shepherd ground covering gait. If you do not know if your dog is suited to the conformation ring, you could ask your breeder or one or more of the knowledgeable breeders in our club for their opinion. If you find that your dog could be a conformation dog, maybe you will want to try showing him yourself or ask a professional or experienced handler or junior handler to show your dog. If you want to show the dog yourself you should take classes to prepare. Puppies are not expected to be perfect in the class and it is OK if they do not know how to stack or gait yet. If you choose to show your puppy yourself just follow the lead of the people around you and try to get your puppy to gait around the ring and stack for the judge. Use treats!

**Obedience**: No treats in the obedience ring! If you are just starting to show your dog in obedience you would start in the pre-novice or novice class. In pre-novice you keep the dog on leash the entire class even for the sit stay (1 minute) and down stay (3 minutes). You have the same exercises as the Novice class except there is no off leash heeling exercise. The judge gives you commands and you and your dog first perform a heeling pattern usually an "L" shaped pattern which includes several sits and about turns a fast time and slow time and some left and right turns. You also do a figure eight exercise usually around two stewards. You will be asked to stand your dog for an exam and will do a recall exercise. As a group, your class will do a sit stay and down stay exercise on leash. In the Novice class you also do a heeling exercise off leash, the stand for exam, recall and sit and down stay exercises are also off leash. Novice is broken up into Novice A and Novice B. If you have never handled a dog who received an obedience title you can show in Novice A. Otherwise you show in Novice B.

**Rally:** Rally also has a Novice A and Novice B class. If your dog has no obedience or rally titles and you have never gotten an obedience or rally title on any dog, you can show in Novice A, otherwise enter Novice B. This level of rally is entirely on leash. You can review the signs used on the AKC site http://www.akc. org/pdfs/rulebooks/ROR999.pdf. Review Virginia Bailey's rally article in the October issue of the Shep-O-Gram. You are allowed to walk the course before the class and ask the judge questions. Once the judge gives you the command "Forward" you are on your own to get through the course. Every sign has a number and you must perform the exercises in order to qualify. I usually count them out to myself as we go. Unlike the regular obedience classes, in Rally you are encouraged to talk to your dog. You can clap your hands or pat your leg. No treats are allowed in the ring or in your pockets though. Rally is a good place to start showing in obedience.

Feel free to ask the people taking entries at the match if you have a question about what class to enter. If they don't know the answer they can direct you to someone who does know. Now get out there and enter the match or at least come to watch on November 16 at 7 PM and enter the next match. Bring a pumpkin pie to share if you like. Remember matches are fun!

#### Awards Presented at Our Annual Banquet in January

If you earned any awards for your dog during 2007, please fill out the attached form in order to be recognized at the banquet. Below is a description of the awards which qualify and how to determine whether you qualify for a plaque or bar.

The Club shall present an award for all titles for Agility, Conformation, Herding, Obedience, Rally, and Tracking Titles issued by the American and Canadian Kennel Clubs. Awards will also be given by the Club for titles earned at the American National & Titles earned from the GSDCA including Conformation, Obedience, Herding and Agility Grand Victor and Victrix, Select or Select Excellent, Maturity Victor/Victrix, Futurity Victor/Victrix, Winners Dog, Winners Bitch, Best Junior Handler, Best Puppy, Top Ten Stud Dog/Brood Bitch, ROM, Highest Scoring German Shepherd Dog in Regular Obedience Classes, Highest Scoring Champion in Obedience, High in Herding Trial, High in Agility Trial, Performance Award of Merit, Award of Excellence (AOE), High in Trial-Tracking. In addition, awards will be given for appearances in the annual Redbook Top 10 living ROM Sires & Dams, and the Top 10 sires & dams of AKC major point winning progeny.

For certificates honored at the AKC and American National level. the club will acknowledge the certificate in the banquet program in a "Honorable Mention" section. Such certificates include: Canine Good Citizen, Herding Instinct and other such certificates.

These awards will be presented to members of the Club in good standing. This requirement may be met by:

- Being a member in good standing at either the time the award is earned or at the date of the Annual Banquet at which the award is to be given or
- By becoming a member applicant by the date of the Annual Banquet at which the award is presented.

The Club will present one plaque award per member's dog. Any additional awards presented to that dog will be in the form of a bar, which will affix to the plaque. A member may purchase a plaque instead of a bar for the difference in cost to the Club. Members and co-owners may purchase their own plaques for awards not recognized by the GSDC – MSP at the cost equal to the amount billed to the Club.
