Meeting came to order at 8:31pm

Minutes: Doug Oster motioned to dispense the reading of the 8/10/07 Membership meeting, Seconded and passed. The Minutes from the 9/12/07 Board meeting were read by Verna Kubik as the Secretary-Conni S. was unable to read due to a cold.

During the reading of the minutes Joan Johnson volunteered to be Show Chair for the 2008 Specialty Show and Sheila Metz volunteered to be Show Secretary for the 2008 Specialty Show. Diane Mehra volunteered to be Match Chair for the next match. Roberta Moore volunteered to be All Breed Liaison. Thank all of you for volunteering and supporting the club.

President's Report: Covered in meeting Vice President's Report: No report Secretary's Report: No report same as in Board Minutes. Treasures Report: No report same as in Board Minutes

Linn Klingel made a Motion to dispense with regular order of business, Mike Metz seconded and passed.

State Fair 2007 Demo Report will be posted on the web, Virginia Bailey said a Big Thanks to all who volunteered to show the public how wonderful and versatile the German Shepherd Dog is. Virginia Bailey requested to be reimbursed for the fair tickets in the amount of \$120.00. Kelly Knight made a motion to reimburse Virginia Bailey in the amount of \$120.00 for purchasing the tickets for the State Fair. Mike Metz seconded and passed.

GSDCMSP Website –internet subscription reimbursement-Craig Carson made a motion that Dave Bissonette be reimbursed in the amount of \$268.42 for payment to the host company for our club website which covers our website for 4 years. Ginny Altman and Liz Oster seconded and passed.

Kelly Salava made a motion to cancel conformation classes on 10/19/07. Gary Weickelt seconded and passed.

Kelly Salava stated that a 2 page ad will run in the Review in memory of Butch Fischer and the remaining donations will be sent to the U of M.

Club Finances/Bank Overdraft: Pam Magadance handed out Financials for Review: Profit and Loss- August 2007 Balance Sheet as of 8/31/07 Cash Activity from 8/31/07-9/11/07

There were many questions that were all answered. Some of the following were:

Q.- How much were the overdraft fees to the club? A.- No overdraft fees were occurred by the club Pam M. paid them out of her own pocket.

Q. What bank did Pam open an account at?

A. S & C in New Richmond which is being bought out by Anchor Bank-they have branches in Minnesota and Wisconsin.

The following requests were made by club members- Open communication is necessary and a request that every check number and want it is written for be listed on the Treasures Report. Also deposits listed as what they are from.

2007 Show Expense Analysis: The following items were passed out for review. Copies are attached.

• 2006-2007 Show Income & expense Comparison

• 5 Year GSDCMSP Show entry summaries

• Comparison of Show Superintendent Fees – we paid an extra \$700.00 to have a Show Secretary versus having a volunteer from the club to handle the paper work like we did in 2006 -Mada Parnell

Key differences from 2006 to 2007 resulting in a net loss for 2007 were:

• an increase in Show Supt. Fees of ~\$750 for paid secretarial services due to lack of a club volunteer show secretary

• increased trophy purchases of \$871 in 200—(total trophy budget \$3000), partially offset by an increase in trophy donations of \$190. Inventory of remaining trophies has been requested. It is likely that we have a significant inventory left for use next year.

• increased food purchases (\$125) due to fewer food donations and lower food sales (\$358) than last year.

• lower entry fee income-Although First entry fees were increased by \$2/dog to offset costs for indoor obedience, and the total entry was comparable for the two years, entry income was ~\$527 less than 2006. We may need to eliminate reduced fees for second entries, non-regular classes, and puppies next year.

• Increased facility expense for indoor obedience and mat rental (\$450), not offset by an increased performance entry as anticipated.

Thank you Pam for clarifying the costs differences in the Specialty show finances for further review.

Liz Oster motioned that the Membership accept the Specialty Show Expense Report and Treasurers Reports, Kelly Salava seconded and passed.

#### By Law Changes

Linda Kofstad a chair on the By law changes Committee briefly explained what changes were made to the Constitution and By laws.

A letter explaining the changes that were made to the Constitution and By laws of the GSDCMSP was sent along the changed Constitution and By laws to all members last month as to be voted at this month's meeting.

Linda Kofstad motioned to accept the Constitution and By law changes to be approved by the membership, Virginia Bailey second. After much discussion about the changes Doug Oster called the question to vote, seconded.

Ginny Altman moved to amend the motion and only those changes that are in Blue to be considered for acceptance. Patrick Miller seconded. Linda Kofstad asked not to accept Ginny A. motion. A vote was taken on only accepted the changes in Blue. It passed with 19 notes.

Mike Metz motioned to add a Budget and Finance Committee with an annual budget to be produced by the December meeting for membership approval, this committee will include the treasurer. Myra Shear seconded. Passed. Amendment will be incorporated into the Bylaws.

Ginny A. motioned to change the wording of Article VI Sec. 3 Special Meetings to read as follows:

A special meeting of the members shall be called by the Secretary either upon the direction of the President or of the Board of Directors. Special meetings of the Club shall be called by the Secretary upon written request of 20 of the Active Paid Members. The Secretary shall notify all members at least 20 days prior to the meeting, stating the date, time and place of the meeting, and the purpose for which the meeting was called. No other business may be transacted at such special meetings. Pam Magadance seconded. Passed.

Ginny A. motioned to change the wording of Article VI Sec 4. Membership Meeting Quorum to read as follows:

A quorum for all membership meetings shall consist of ten active members, two of which must be officers of the Club. Kelly Knight seconded. Passed

Ginny A. motion to change the wording of Article III Sec. 2, letter C to read as follows-

An applicant must attend at least two-sponsored events within one year from the date of the application. Diane Mehra seconded. Passed.

Ginny A motioned to adopt D. under Article III Sec. 2, wording in pink.

Pam M seconded. Passed.

Ginny A motioned to adopt E. under Article III Sec. 2 wording in pink, Diane M. seconded. Passed.

Ginny A motioned to change the word Board Meeting to Membership meeting under numbers 1, 2, 3, and 4. Article III Sec. 2. Lynn Klingel seconded. Passed. Ginny A. motioned to change the wording in Article III Sec 3 Membership dues to read as follows:

The amount of the dues shall be set by the discretion of the membership and may be changed upon a majority vote of those present at a regular membership meeting or at a Special Membership meeting called for that purpose. If a quorum is not obtained for that meeting, the vote for the change in the amount of dues will take place at the next regularly scheduled membership meeting with previous notice mailed to the membership of a proposal to increase dues 20 days prior to the meeting at which it is to be considered.

Sharon Todoroff motioned to table discussion until next Friday September 21, 2007. Bobby Moore seconded. Passed.

Meeting adjourned at 10:47pm. \

Special Meeting continuation of 9-14-07 meeting came to order at 8:31pm

Continuing on with the By laws changes were adopted last meeting all changes in blue and pink up to Article VI Sec.4 on page 5 by the members that were present last week.

Starting at Article VI Sec. 5 Board meetings:

Ginny Altman motioned to change the wording to read as follows:

The Board of Directors shall meet monthly at a time and place to be designated by the President. Minutes of the Board Meeting shall be published on the GSDC-MSP Web Page, in the next issue of the Shep-O-Gram and read at the following Membership Meeting. Connie B. seconded. Open for discussion.

Motion was amended by Verna K. to have it read Board and Membership meetings. Virginia B. seconded. Passed

Article X Sec. 3 Board Hearings: Ginny A. motioned to adopt Article X Sec. 3. Connie B. seconded. Passed.

Article X Sec. 4 Expulsion

Ginny A. motioned to change the wording to read as follows:

Expulsion of a member from the Club may be accomplished only at a special meeting of the Club following a Board hearing and upon the Board's recommendations as provided in Section 3 of this Article. Such proceedings may occur at a special meeting of the Club to be held within 60 day, but no earlier than 30 days after the date of the Board's recommendations of expulsion. If a special meeting of the membership is called and a quorum is not reached, adjourned meeting shall be set 20 days, with notice sent to the membership. The defendant shall have the privilege of appearing in his own behalf, though no evidence shall be taken at this meeting. The President shall read the charges and the Board's findings and recommendations, and shall invite the defendant if present, to speak in his own behalf if he wishes. The members shall then vote by secret ballot on the proposed expulsion. A two thirds vote of those present and voting at the meeting shall be necessary for the expulsion. If expulsion is not so voted, the Board's suspension shall stand. Mike M. seconded. Passed.

Ginny Altman motion to change the wording under Article 1 to read as follows:

The name of this organization shall be known as the GER-MAN SHEPHERD DOG CLUB OF MINNEAPOLIS AND ST. PAUL. For a shorter reference, this Club shall be known as GSDC-MSP. Craig Carson seconded. Passed.

Ginny Altman motioned to change the wording under Article II A. to read as follows:

A. The objects of the Club shall be to promote the breeding of the German Shepherd Dog: to procure the adoption of the Standard of the German Shepherd Dog as approved by the American Kennel Club, by breeders, judges, dog show committees and others as the recognized Standard by which this breed shall be judged; to protect, advance and improve the interests of the breed by offering prizes, giving and supporting breed and obedience shows; and in general to aid by every possible means in demonstrating its conspicuous abilities as Companion, War, Red Cross, Police, Herding and Lead Dog for the blind. Also to bring together, help and encourage all German Shepherd Dog owners in every way without discrimination against any person on the basis of race, color, age, sexual preferences or religion. Mike M. seconded. Passed.

Ginny Altman motioned to change the wording in the second paragraph to read as follows: Dues shall be assessed on a yearly basis from October 1 through September 30; provided that the dues of the members elected during the months of July, August, or September, shall commence with October 1 of the current year. Annual dues shall be billed on September 1 and payment must be postmarked by November 15, together with any other indebtedness owning to the Club. Roger Salava seconded. Passed.

#### Article IX Committees

Ginny Altman motioned to add the Budget and Finance Chairman after Membership Chairman under Section 1. A. Craig C. seconded. Passed.

#### Article IV Government

Ginny Altman motioned to accept the changes on page with the exception of Section 3 which was previously struck from adopting. Dave B. Seconded

Kelly Knight motioned under A. President shall ensure the Treasurer, Director of Training and all signatories on bank accounts be bonded. Joe K. seconded. Open for discussion.

After much discussion about who should or should not be bonded and many amendments that were not passed by the members concerning bonding the following motion was made:

Bo. V. motioned to amend the motion to read as The President shall ensure the Treasurer and signatories on bank accounts be bonded. Dave B. seconded. Discussion followed and then vote was taken 9 yes, 14 no defeated.

Ginny Altman motioned to have all signatory on the bank accounts be bonded. Dave B. seconded. Passed.

Ginny Altman motioned to accept the whole page with the exception of Sec. 3(wording in pink). Dave B. seconded. Passed.

Ginny Altman motioned to accept all new wording changes in red on page 5. Craig C. seconded. Passed.

Ginny Altman motioned to insert the Budget and Finance Chairman under Section 1 A. after Membership Chairman and under Section 2 a new letter E. Craig C. seconded. Passed.

Ginny Altman motioned to accept the rest of page 6 as worded. Mike M. seconded. Passed.

Ginny Altman motioned to accept the wording under Article X Discipline Sec. 2. Mike M. seconded. Passed.

Ginny Altman motioned to accept the wording in Article X Sec. 3. Connie B. seconded. Passed.

Ginny Altman motioned to make Article XII Order of Business to become a new section listed a Section 8 under Article VI. Article XI to contain Roberts rules which then Article XI Amendments becomes Article XII. Dave B. seconded. Passed.

Ginny Altman motioned to move Adoption and Revision to the bottom of the page and not be a section. Mike M. seconded. Passed.

# Rally Obedience

Rally Obedience is a sport designed to bridge the gap between CGC (Canine good citizen) and regular obedience competition.

The rules in Rally are more relaxed than in regular AKC obedience competition. You are encouraged to help your dog as you progress through the course. You may use both verbal and hand signals, you may clap your hands or pat your leg if your dog gets distracted. You can even retry an exercise if you do it wrong the first time. You can still qualify if you make a mistake, as long as you achieve the minimum number of points (70 of a possible 100).

The skills your dog needs to perform in a Novice Rally class are: walk on a loose leash, sit, down, stay while the handler walks around the dog, come to front as the handler backs up, finish to the left and finish to the right. All Novice Rally exercises are done on leash. The skills the handler needs are walking and reading the signs in front of you.

If your dog has been through a basic obedience class and will work on a loose lead, try Rally! I would recommend that you take a few Rally classes so the trainer can help you to understand the correct way to do the rally exercises; then get out and earn your title.

The attitude around the Rally obedience ring is very positive. Everyone wants to see everyone else succeed.

## Foods to Avoid Feeding to Your Pet—and Why:

From the ASPCA web site

Alcoholic beverages—these can cause vomiting, diarrhea, drunkenness (ataxia), central nervous system (CNS) depression, tremors, difficulty breathing (dyspnea), or panting, respiratory failure, acidosis, coma or death.

Avocado—rabbits, mice and birds in particular are pets susceptible to poisoning. symptoms seen are respiratory distress, fluid accumulation around the heart and death.

Chocolate (in all forms)—can cause vomiting, diarrhea, hyperactivity, panting, abnormal heart rhythm, tremors seizures and death, depending on the dose ingested.

Xylitol—candies, gum or other foods sweetened with xylitol can cause a rapid drop in blood sugar, resulting in lifethreatening tremors and seizure activity, as well as the potential for liver failure.

Coffee (in all forms)—can produce the same effects as chocolate, depending upon the dose.

Fatty foods—can cause vomiting, diarrhea and abdominal discomfort. Can also result in an inflammatory condition of the pancreas (pancreatitis), particularly in dogs.

Macadamia nuts—can produce weakness (particularly in the hind legs), depression, vomiting, ataxia and tremors. Thus far, dogs have been the only species reported to the ASPCA/APCC that are effected by ingestion of this species of nut.

Moldy or spoiled foods—may contain certain molds that release toxins which can cause vomiting, severe tremors, seizures and death. Spoiled food can also contain bacterial toxins which can produce severe food poisoning signs.

Onions, onion powder—can produce vomiting, diarrhea, and can cause significant damage to red blood cells.

Raisins and grapes—ingestion of these fruits have been associated with acute kidney failure in dogs. Most dogs initially vomit and drink a lot of water. They then develop diarrhea, kidney failure and, finally, death.

Salt—can produce sodium ion poisoning which causes vomiting, depression, tremors, excessive thirst, diarrhea, excessive urination, elevated body temperature, seizures and death if a large enough amount is consumed.

Yeast dough—yeast-based dough can not only expand in the stomach as it rises, causing an obstruction or intestinal rupture, but yeast can form alcohol when it rises, which can cause alcohol poisoning.

As for cheese, dogs and cats are relatively lactose intolerant. Therefore, too much of a dairy food could cause gastrointestinal upset, including vomiting and diarrhea.
