Bloat, also known as Gastric Dilatation Volvulus (GVD) or Gastric Torsion

There are a number of gastrointestinal conditions in the dog that result in obstruction of the gastrointestinal (GI) tract and lead to the need for emergency treatment. The most common, for those of us with German Shepherd Dogs, is bloat, also known as acute Gastric Dilatation Volvulus (GDV), or torsion. This article will discuss GDV but first let us review the anatomy of the canine gastrointestinal tract.

The stomach lies just below the diaphragm and is an organ that can vary greatly in size. It is shaped like the letter "C" lying on its side. Its function is to store and mix food with enzymes, mucus, and hydrochloric acid, which are produced by the stomach. The stomach is situated on the left side of the dog and when empty lies in contact with the liver, but when distended extends beyond the liver in contact with the diaphragm and the abdominal wall. The inlet to the stomach from the esophagus is called the cardia. The outlet is the pylorus, which unites the stomach to the duodenum. The body of the stomach is known as the fundus and together with the pylorus and cardiac portions make up the pouch-like organ we know as the stomach.

The small intestine extends from the pylorus at the outlet of the stomach to the opening of the ascending colon. The small intestine is approximately three and-one-half times the length of the dog's body. It's made up of three parts: the duodenum, jejunum, and the ileum. The duodenum is about ten inches long and is rather fixed. The jejunum is the longest and most mobile part of the whole digestive canal. The ileum is the terminal part of the small intestine. As food enters the duodenum from the stomach it is mixed with pancreatic enzymes, bile from the liver, and secretions from intestinal glands. Food takes approximately eight hours to pass through the small intestines to the large intestines. Eighty percent of the water content of food is reabsorbed here.

The large intestine is a simple tube, only slightly larger in diameter than the small intestine. Its principal function is to complete the reabsorption of water as the food passes through the bowel. The large intestine is comprised of the cecum, colon, rectum and anus.

The bowel receives its blood supply through a fold of peritoneum called the mesentery. The mesentery varies in width from one to fourteen inches and contains blood vessels, lymph glands, nerves and fat. The length of the mesentery matches the length of the intestine to which it is attached and this attachment follows the turns and folds of the intestine.

Bloat, Gastric Dilatation Volvulus (GDV or Bloat/Gastric Torsion is a life-threatening condition that is not uncommon in the German Shepherd Dog. In this condition the fundus of the stomach turns 180 degrees or more within the abdominal cavity and pinches off its own blood supply. Envision that it rolls over on itself and twists the opening from the esophagus and the outlet to the duodenum or small bowel. It can come on quite suddenly as a rapid enlargement of the abdomen but can also be present in a more subtle way before abdominal bloating is observed.

The more subtle symptoms of bloat are that the dog may regurgitate water or foamy saliva. This may progress to repeated drinking and regurgitation or the dog may instead retch time and again without bringing up either food or water. The dog may also begin to salivate or drool copious amounts of saliva. Initially the dog may appear restless, pacing about, seeming to be unable to find a comfortable position. The dog may get up and lie down repeatedly and seek contact with his human companions. When the full-blown syndrome is manifested, the dog is in acute distress. The dog may refuse to lie down, preferring to sit or stand continuously in an effort to relieve pressure on the diaphragm. The gastric dilatation volvulus (torsion) compresses the major blood vessel to the liver (the portal vein) and the major vessel that returns blood to the heart (the vena cava). The ability of the heart to pump blood is compromised and the dog's blood pressure drops. Breathing becomes difficult because of the pressure on the diaphragm and lungs. The tongue, gums, and the inside of the lips become very pale or cyanotic (blue) and the dog may collapse within minutes.

Be suspicious of any change in your dog's behavior. If your dog is not feeling well and gives any of these signs, suspect bloat—and get your dog to the vet quickly! Once the condition is recognized, attempts to decompress

the stomach should be instituted immediately. If attempts to pass a tube down the esophagus into the stomach to relieve the air pressure fail, it may be necessary to relieve the pressure in the distressed dog by placing a needle into the stomach to evacuate the gas in order to relieve the dog's critical condition. Steps need to be taken to stabilize the dog by administering intravenous fluids, antibiotics, and steroids. Exploratory surgery is often needed to untwist the stomach. In surgery, the stomach wall will be inspected for any area that is damaged and does not regain an adequate blood supply. This area will need to be excised. Not uncommonly, the spleen, which is located in close proximity to the stomach, will also have twisted upon itself and will need to be removed. The stomach is then tacked to the abdominal wall in a procedure called gastropexy. The gastropexy is an attempt to prevent another occurrence of gastric torsion because dogs that have had GDV are prone to a reoccurrence.

Following recovery from surgery, gradual small feedings are begun. Once the dog is discharged to home, it is recommended that the dog's normal diet be divided into three or four feedings per day and that exercise be limited within the first hour or two following eating.

The onset of this condition can be so rapid that it escapes attention until it is too late. Owners have found that their dogs have died sometime during the night or while they were away during the day. It must be noted that about 20 to 40 percent of these dogs will die regardless of the treatment. The risk increases to 40 to 60 percent if it necessary to have part of the stomach removed for inadequate blood supply.

At one time it was thought that males were predisposed to this condition but this has not been supported by recent evidence. The cause of GDV remains uncertain although the greatest incidence is in deep-chested dogs. Some authorities suggest that it is associated with exercise after eating. Others suggest that a single feeding per day predisposes an animal to this condition. Research studies that have been done, however, have not correlated feeding habits or type of food with the development of GDV.

How do you say goodbye to a special friend whose life tragically ends? She was in the prime of her life which found her playing, romping, jumping and behaving like a puppy, the previous afternoon. In fact Tifany had been looking so nice I had her "primped" for the weekend of 4 dog shows.

Saturday morning found me loading 3 dogs (Tifany, Natalie & Little John) for the local UKC dog shows. First thing in the morning Tifany threw up and did not eat her breakfast. I debated about taking her along to the show and usually would have left the dog in question at home, but I guess fate intervened. How tragic if she had not been with me!

At the show, I discovered Tifany had an enlarged stomach that looked like she was pregnant. It also felt extremely hard. I rushed her to the U of M Emergency Clinic. Radiographs revealed a mass in her abdomen with air in the intestinal tract. Her glucose was 30 vs 85 & heart rate was extremely fast. The vet said it could either be "a mass of tumors" or "gastric torsion/bloat".

They gave her fluids, which seemed to stabilize her and even put a wag back in her tail. I hugged & told her "KEEP WAGGING YOUR TAIL TIF, KEEP WAGGING IT FOR ME, I WILL SEE YOU LATER"! With that she was taken off to prep for surgery and I returned to the dog show. Unfortunately, her stomach was torsioned (twisted) a couple of times and she did not pull through. In my 40 years of breeding German Shepherd Dogs, I have never had bloat/torsion in my dogs.

Her mother, ANNIE (just celebrated her 13th birthday on 11-16-7) – Mari's TiffAnnie Rose ALee OFA H/E; TC; CGC; retired therapy dog, is still alive and doing well.

Verna received a phone call from Jan McKim, regarding the State Fair demo for Shepherd Day. It offers an opportunity for all aspects of the GSD to be presented and for our Club to be spotlighted before the

State Fair attendees. The demos will no longer be indoors, but in the outdoor area across from the building. Some type of demo will also take place all day long during the Fair hours. This will present a challenge in finding enough volunteers to man the timeframe required because the date is Sunday, August 31st of Labor Day weekend.

- 16 New Business: None.


