On May 12, 2010 the Grand Championship competition will start concurrent with the implementation of the 2010-2011 Schedule of Points. Competition for this new title will be judged concurrently with Best of Breed competition at both all-breed and specialty shows.

How does a dog earn the Grand Champion title?

- Only Champions are eligible to earn Grand Championship points. (This includes dogs that are "moved up" to Best of Breed competition from completing the requirements for their CH title at a previous show.)
- Best of Breed, Best of Opposite Sex, Select Dog and Select Bitch are eligible to earn Grand Championship Points. Select Dog and Select Bitch are Champions that were recognized as the top quality of their sex after BOB and BOS have been awarded. Judges need not award Grand Championship points to dogs that in their opinion are not worthy of the award.
- Grand Championship points are earned using the same schedule of points as is used for Championship points and the title requires:
 - o Twenty five Grand Champion points including,
 - o three "majors" (three or more points) won under three different judges,
 - o and at least one or more of these points won under a fourth judge.
 - o They must also have defeated at least one other AKC Champion at three shows.

How are Grand Championship points determined?

- Grand Championship Points are determined using the schedule of points for each breed in each division. However, all dogs defeated by BOB, BOS, Select Dog or Select Bitch will be counted in the computation. Grand Champion points may be awarded to eligible dogs as follows:
 - Best of Breed All dogs of the both sexes in the breed or variety exhibited in the regular classes and Best of Breed competition will be counted.
 - Best of Opposite Sex to Best of Breed All dogs of the same sex in the breed or variety exhibited in the regular classes and Best of Breed competition will be counted.
 - Select Dog or Select Bitch One dog less that the number of dogs of the same sex in the breed or variety exhibited in the regular classes and Best of Breed competition will be counted.
 - Champions of Record including champions that are non-regular class winners or dogs that have been "moved up" to Best of Breed competition for the show are the only dogs eligible for Grand Championship points. Although class dogs can win BOB or BOS, they have not yet obtained their CH title and are not eligible for Grand Champion competition. (*Dogs entered in non-regular classes are not counted in the computation of*
- since 1/1/2007 to inform them of this new opportunity to showcase their dogs.

GRADUATE NOVICE OPTIONAL TITLING CLASS

 Section 1. Graduate Novice Class. The Graduate Novice class shall be for dogs that have not won a Graduate Novice title (GN). The Graduate Novice class is an optional class that may be offered by clubs at obedience events. Judges for this class must be approved to judge Novice or higher classes. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. However, if a person has handled more than one dog in the first five exercises, that person must provide a handler for the additional dog in the same Long Down exercise. If eligible as defined in these regulations, dogs entered in Graduate Novice may also be entered in any other obedience classes. Judging will be as in the regular classes.

The exercises, maximum scores and order of judging:

- 1. Heel on Leash and Figure Eight (off leash)40 points2, Drop in Recall40 points3. Dumbbell Recall30 points4. Recall Over High Jump30 points5. Recall Over Broad Jump30 points6. Long Down30 pointsMaximum Total Score200 points
- Section 2. Graduate Novice Title. The letters GN may be added after the name of each dog that has been certified by three different judges to have received qualifying scores in Graduate Novice classes at three licensed or member obedience trials. That dog will receive a Graduate Novice certificate from the AKC.
- Suggested judging rate is eight dogs per hour.
- Section 3. Graduate Novice Exercises and Scoring.
- Heel On Leash and Figure Eight. The exercise and scoring will be executed in the same manner as the Novice Heel on Leash and Figure Eight, except that the Figure Eight will be done off leash.
- Drop on Recall. The exercise and scoring will be executed in the same manner as the Open Drop on Recall, except that the handler may give the command and/or signal to drop the dog.
- Dumbbell Recall. This exercise will be performed like the Novice Recall but with the dog holding the dumbbell. In addition to the Novice Recall, the dog will promptly take, hold and deliver the dumbbell when commanded.

Moving Stand and Examination. The exercise and scoring will be the same as in the Utility Moving Stand and Examination, except that the handler may pause or hesitate when giving the command and/or signal to stand.

Go Out. The principal features of this exercise are that the dog go away from the handler to the opposite end of the ring and stop as directed. The orders are: "Send your dog" and "Return to your dog."

The handler will stand in the approximate center of the ring between the jumps facing the unobstructed end of the ring. The judge will order "Send your dog," and the handler will command and/or signal the dog to go forward at a brisk trot or gallop to a point about 20 feet past the jumps in the approximate center of the ring. When the dog reaches this point, the handler will give a command to sit. The dog must stop and sit with its attention on the handler, but it need not sit squarely. The judge will then order the handler, "Return to your dog," and the handler will return to the heel position.


Directed Jumping. The principal features of this exercise are that the dog stay where left, jump as directed, and return to the handler as in the Novice Recall. The orders are: "Leave your dog," "Bar," "High" and "Finish."

The handler will stand with the dog sitting in the heel position at the unobstructed end and in the center of the ring. The judge will order "Leave your dog," and the handler will walk to the far end of the ring and turn to face the dog. The judge will order either "Bar" or "High" for the jump, and the handler will command and/or signal the dog to return to the handler over that designated jump. While the dog is in midair, the handler may turn to face the dog as it returns. The dog will sit in front of the handler, and, on order from the judge, finish as in the Novice Recall. The dog will be sent over only one jump, and the same jump will be used for all dogs as designated by the judge at the start of the class.

Obedience ring jitters

After all these years I still get nervous before I enter the ring. Most handlers do, no matter how long they've been in the sport. Not to worry. If we didn't get nervous, it would mean we no longer cared about how we did, so a bit of nerves is normal and even desirable. The trick is to control those jitters so they don't take over.

And how do we manage this? Well, we all know that we transmit those nerves right down the leash, so the first step is to let the dog relax in peace, to save up the energy he's going to need. So into the crate (or car) he goes.

MAKE YOUR WARM-UP WORK

This doesn't mean there should not be a warm-up, but you have to plan it so it helps you. We often see beginner handlers warming up all day long before they go into the ring. Unfortunately, all this working out does not help, as the handler is usually very anxious, so the dog ends up anxious and exhausted. So keep it short. Don't try to completely retrain the dog an hour before ring time.

It is not only beginners who make things worse in their warm-up. Too many people go off and practise the wrong thing. For example, let's say you have a problem with the retrieve, so you find a practice area, remove the leash, get the dog into a sit at heel, throw the dumbbell and then send him. If he goes off and gets his dumbbell, well and good, but what if he chooses not to go? Or what if there's an 'attack crate' lurking near the dumbbell and he gets a scare? What if a few spectators walk by and he goes to greet them? Have you accomplished anything other than setting the dog up for failure and making your own nerves worse? No. So it is very important to plan your warm-up. If I have a problem exercise, I would probably opt to practise it beforehand, but I would usually keep the leash on so I can control the situation. This not only gives your dog the idea that he has no choice in the matter, but it also shows him that he can succeed. And it certainly helps the handler's nerves to have the dog do it correctly.

STAY POSITIVE

The mental preparation is just as important as the physical. So the next step is to take control of your thoughts. Of course, it's normal to watch the dogs in the ring and think of all the ways there are to fail, how many of them your dog has already figured out, and how many new ways he's likely to find in the very near future. But a little of this self-indulgence goes a long way. Instead, spend a few minutes visualizing yourself and your dog performing the routine, exercise by exercise.

Should you chat up the other exhibitors? Whether it will help to distract you or just make you more flustered depends on the individual. But whichever way works for you, set aside time for yourself shortly before you go into the ring, to focus and put yourself in a proper (and positive) frame of mind. As for chatting up the judge, while there's no harm in this, and it might help to relieve a bit of your stress, don't overdo it. Once in the ring you need to focus on your dog and your routine.

YOUR JOB

Have you ever tried to reassure your dog when he's nervous? The trick is to distract him by giving him something else to think about. The same method can work for us. Instead of thinking all those negative thoughts, think about your job.

Your job is to be the very best team member you can possibly be. Your job is to help your dog in every legal way you can. Your job is to be smooth and clear in your handling, so the dog knows where he's going and what he's supposed to do. So use that nervous energy to study the routine and plan your strategy.

The judge calls for the signals quickly? Plan to wait a second or two before responding. There isn't much room to do the fast? Plan to be ready to do your transitions right away so you won't have to do your about turn in the ring entrance. Where do you have to turn to make it down the middle mat for the Signals? Should you throw

your dumbbell a little to the left or a little to the right? Once you are in the ring, concentrate on those details, one exercise at a time. You probably won't remember everything, but it will give you something positive to think about and take your mind off the pass/fail concept.

Once you enter that ring, you are somewhat at your dog's mercy (admittedly a scary thought). But don't worry. Your training is done, you are as ready as you can possibly be, and no matter what happens, there will always be another dog show. So take a deep breath, relax smile, and enjoy the moment.

Review of the Comfy Cone by Julie Swinland

I would like to share my experiences with a fairly new product, the Comfy Cone. I bought one of these when Gabby was spayed a year ago since she comes from a long line of staple pullers. The vet didn't use staples, but I didn't want to take a chance that Gabby might extend her family talents to stitch pulling. It happened that the same day she was scheduled for surgery I discovered that her mother, Amy had pyometra and was rushed in for surgery also. So I had two potential staple or stitch pullers to watch over and I had to go to work. Amy was an accomplished staple and stitch puller from previous surgeries. She had a Cesarean to help her bring Gabby into the world. So the two shared many bonds and Amy's mom, Sabrina was also a staple puller.

My previous experience had taught me that the cones the vet's office provides are neither comfortable nor practical. The solid plastic is inflexible and gets caught on everything. SO when I brought Gabby and Amy home to recover I was desperately looking for something else. I found the Comfy Cone at PetCo. I believe it cost around \$18. It was easy to wash off, flexible, and the dog could see much better than with the hard white plastic cones of vestervear. . It is also padded and seems like it would be well, comfy. I had actually been looking for a clear plastic cone when I found the Comfy Cone. There must have been a run on those and I could not find any. PetCo had just gotten the Comfy Cone in. I bought Amy a Comfy Cone also, but she didn't seem to need it and I got by with a borrowed very soft floppy cone that a friend got from her vet. That worked well for her. The comfy cone seemed to work fine for Gabby, was easy to take on and off with Velcro and did not seem to cause the discomfort that the solid cones had caused my dogs in the past.


