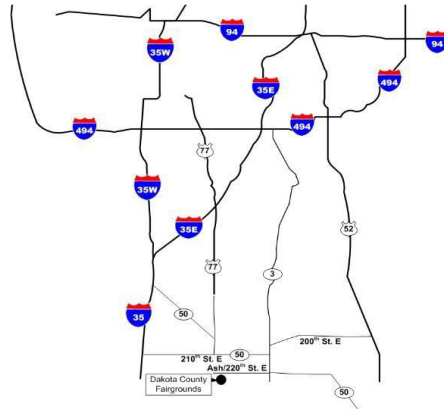

From North or South I35 – Take I35 to Hwy 50. Follow East to Cedar Avenue. Follow Cedar south (right) to Hwy 50. Follow Hwy 50 East (left) to Denmark Ave. Follow Denmark South (right) to 220th St West. Turn Left onto 22nd St West to Fairgrounds entrance on right-hand side.

From North or South Hwy 52 – Take Hwy 52 to Hwy 50. Follow Hwy 50 West to Hwy 3. Cross Hwy 3 to Ash/220th St West. Follow Ash/220th St to Fairgrounds on left-hand side.
