dogs of the same breed that are eligible under these Regulations and capable of performing the Novice exercises. The dogs need not be owned by the same person but will be handled by one handler. Dogs may be shown unattached or coupled (the coupling device will not be less than 6 inches in overall length). Whichever method is used will be continued throughout all exercises. A separate official entry form will be completed in full for each dog entered.

Exercises, performances and judging will be as in the Novice Class. The brace should work in unison at all times. Either or both dogs in a brace may be entered in another class or classes.

Search and Rescue Dogs

The use of **dogs** in **search and rescue** (SAR) is a valuable component in responding to requests for lost and missing persons. Dedicated handlers and hard working, well-trained dogs are required in search efforts to be effective in their task.

Search and rescue (SAR) dogs detect human scent. Although exactly what this means to the dog is not known, it may include skin rafts, evaporated perspiration, respiratory gases, or decomposition gases released by bacterial action on human skin or tissues.

Types

Search and rescue dogs can be generally classified as *airscenting*, *tracking*, or *trailing*. Airscenting dogs primarily use airborne human scent to home in on subjects, whereas tracking and trailing dogs rely on scent deposited on the ground by the subject. Airscenting dogs typically work off-lead, are non-scent discriminating (eg, locate scent from any human as opposed to a specific person), and cover large areas of terrain. Although other breeds can be trained for airscenting, the prototypical airscenting dog is a herding (eg, German or Belgian shepherds, Border Collies) or sporting (eg, Golden or Labrador retrievers) breed that has a reputation for working closely and in coordination with a human handler. Tracking and trailing dogs are usually scent discriminating and require an uncontaminated scent article from the subject and a relatively undisturbed search area, work on-lead to follow the subject's path, and may use non-human scent (eg, crushed vegetation, disturbed earth) in following the subject's movements. The bloodhound is the prototypical tracking dog, although herding and sporting breeds are often successfully trained for either tracking or trailing.

Specific applications for SAR dogs include wilderness, disaster, cadaver, avalanche, and drowning or recovery.

In wilderness SAR applications, **airscenting dogs** can be deployed to high-probability areas (places where the subject may be or where the subject's scent may collect, such as in drainages in the early morning) whereas tracking/trailing dogs can be deployed from the subject's last known point (LKP) or the site of a discovered clue. Handlers must be capable of bush navigation, wilderness survival techniques, and be selfsufficient. The dogs must be capable of working for 4-8 hours without distraction (eg, by wildlife).

Disaster dogs are used to locate victims of catastrophic or mass-casualty events (eg, earthquakes, landslides, building collapses, aviation incidents). Many disaster dogs in the US are trained to meet the Federal Emergency Management Agency K9 standards for domestic or international deployment; advanced agility and off-lead training are prerequisites reflecting the nature of these dogs' application. Disaster dogs probably rely primarily on airscent, and may be limited in mass-casualty events by their inability to differentiate between survivors and recently-deceased victims.

Human Remains Detection (HRD) or **cadaver dogs** are used to locate the remains of deceased victims. Depending on the nature of the search, these dogs may work off-lead (eg, to search a large area for buried remains) or on-lead (to recover clues from a crime scene). Airscenting and tracking/trailing dogs are often cross-trained as cadaver dogs, although the scent the dog detects is clearly of a different nature than that detected for live or recently-deceased subjects. Cadaver dogs can locate entire bodies (including those buried or submerged), decomposed bodies, body fragments (including blood, tissues, hair, and bones), or skeletal remains; the capability of the dog is dependent upon its training.

Avalanche dogs work similarly to airscenting, disaster, or cadaver dogs, and must be able to rapidly transition from a wilderness SAR-airscenting scenario to a disaster scenario focused on pinpointing the subject's location.

The Magic Bullet Fund

There are about 65 million pet dogs in the US today. It's estimated that half of them will have cancer. Today, pets are thought of as family members and receive excellent care. Even so, too many devoted caretakers are unaware of the high incidence of canine cancer and treatment options for dogs with cancer.

One caretaker who is very well informed on this subject is Laurie Kaplan, medical animal writer and founder of the Magic Bullet Fund. The Magic Bullet Fund provides financial assistance to people who have a dog with cancer but cannot afford treatment costs. This fund is unique in three ways: 1) It is not affiliated with a specific clinic, veterinarian or region. The fund works with a dog's caretakers and their veterinarian, anywhere in the U.S., to enable that dog to receive treatment; 2) The fund does not contribute to cancer research or to finding a cure – rather, it provides cancer treatment to real life dogs who would not otherwise have treatment at all; 3) It brings together all facets of the dog-health community to work toward a common goal. Caretakers, veterinarians, pet supply companies and pharmaceutical companies all interact with and support the Magic Bullet Fund.

Laurie and Bullet's story has become a legend among dog lovers. Laurie was editor in chief of Catnip newsmagazine from Tufts University School of Veterinary Medicine when her Siberian Husky, Bullet, was diagnosed with lymphoma. Laurie's experience as a writer and editor of medical materials about pets gave her a head start for her new mission – to fight Bullet's cancer and give him a chance to survive. While Laurie waged a triumphant war against Bullet's cancer, her colleagues and veterinarians urged her to write a book to help others fighting cancer for their dogs. In late 2001, seeing that there was still no such book available, she set about writing one.

Laurie helped Bullet beat cancer and in mid 2004, when her book was ready for print, Laurie searched for an organization to which she could donate a portion of proceeds. She found organizations that contribute to "finding a cure for cancer" or to "canine cancer research," but this was not what she wanted. She wanted to donate her proceeds to an organization that actually pays for treatment for dogs with cancer.

Finally, just days before her book went to print, Laurie found the Perseus Foundation and its president, Tom Nelson. This foundation provides an information-packed web site about cancer in pets and its Board of Directors includes veterinary oncologists across the country. Mr. Nelson agreed that if Laurie would serve as administrator and handle all aspects of a new fund for the purpose she proposed, the foundation would serve as an umbrella for her fund. Laurie immediately accepted this offer, established procedures for the new "Magic Bullet Fund," created a web site and began to collect donations for the Magic Bullet Fund.

The book, "Help Your Dog Fight Cancer," has become an essential resource for thousands of people fighting cancer for their beloved dogs. It is the top selling book about canine cancer at Amazon.com. In 2007, Laurie co-authored a book called "Canine and Feline Geriatric Oncology," a text for veterinarians.

On November 20, 2004, Bullet went to the fabled "Rainbow Bridge," where beloved pets go when they leave this world. He was nearly 14 and cancer free, with 4+ years in remission from lymphoma. His medical team dubbed him: "The Magic Bullet." On the one-year anniversary of Bullet's passing, Laurie accepted the first dog into the Magic Bullet Fund. Regal, a Doberman Pinscher in NJ (caretaker Shirley Stack), was the first Magic Bullet Fund dog. In the subsequent 2 years, the fund has helped 25 more dogs and their people.

The Magic Bullet Fund has touched the entire community. Generous pet lovers across the U.S. send donations. Veterinarians donate in tribute to patients they lose to cancer, and display a MBF donation box in their clinic's waiting room. Pet related companies donate to finance the Magic Bullet Fund's fundraising campaigns. Veterinary pharmaceutical supply companies partner with the fund to provide discounted drugs for the treatment of Magic Bullet Fund dogs in chemotherapy. Laurie Kaplan continues to donate proceeds from her book.

Guide to Hiring a Professional Dog Handler

A professional handler is a person qualified by virtue of their experience and ability to show another's dog for a fee. A true professional abides by a code of ethics, and is educated and experienced in the sport of showing dogs. They devote much of their time to the expert care, conditioning and exhibiting of the purebred show dog. The professional handler maintains appropriate kennel facilities, and vehicles equipped for safely transporting client dogs.

When considering using a professional handler, here are a few thoughts to keep in mind:

1. The professional handler will evaluate your dog's potential as a show dog.

2. The professional handler will educate you in areas of conditioning, training and grooming in order to make them competitive in the conformation ring.

3. The professional handler can devote the time required to condition your dog both mentally and physically to take on the stamina required for shows.

4. The professional handler will use their experience to present your dog to the best of its advantage.

5. The professional handler has the ability to exhibit your dog in a wide geographic area, taking advantage of shows where the dog can best perform and win.

6. The professional handler can earn a championship on the dog in less time and expense than the ownerhandler.

When choosing a professional handler, ask these questions:

1. Inquire about the kennel facilities. Generally speaking, the kennel should have permanent housing indoors with room enough for the dog to walk around without being cramped. There should be exercise areas outdoors. Grooming areas should be clean; and proper feeding and training equipment available.

2. Ask for a personal inspection of the kennel, facilities, and vehicle in which your dog will travel to shows with the handler

3. Ask who will maintain control over your dog when the handler is not available

4. Ask about your dog's daily routine, veterinary care, and how the dog will be cared for at the shows Members of the PHA are easily identified by the PHA emblem they wear at dog shows and other related events.

A professional handler will have a fully equipped vehicle with crates, exercise pens, grooming, feeding and watering equipment to provide care in all types of weather while at a show. Make it a point to observe the handler's area at indoor and outdoor shows.

Professional handlers are a valuable source of knowledge in the sport of purebred dogs. Not only are their services available to clients, but also they are in demand by kennel clubs to judge match and sweepstake events, and organizing grooming and parking at dog shows. Many handlers offer lectures on a variety of topics to assist in educating the general public on animal welfare issues.

The largest organized professional handler group in the United States governed by a Code of Ethics is the Professional Handlers' Association (PHA). A membership list can be obtained from the above address.

- 5 Treasurer's Report:

 - Checking balance due to outstanding checks of \$1,322.90.


