Meet Tate, a German Shepherd/Australian Shepherd mix currently in training to be a service dog for a Veteran with Post Traumatic Stress Disorder (PTSD) or other traumatic brain injuries.

Tate was a stray from Lake Traverse who found his way to FaerieLand Corgi & German Shepherd Rescue. When we started fostering Tate, I knew that there was something special about him. He was immediately willing to please and wanted to learn; he loved to be

around people and help. Within a few days of fostering him, I had him meet the director of the Patriot Assistance Dogs (PAD) program, and she also agreed that he would be a perfect candidate for training.

Patriot Assistance Dogs fill a specific demonstrated need created by a veteran's disabilities. The goal of PAD is to place these much-needed assets with a veteran, at no charge. The dogs used in this program may be donated, rescued or bred for the program.

Each Patriot Assistance Dog is trained to meet individual veterans' needs by:

- Reminding the veteran to take medication
- Interrupting harmful behavior
- Leading the veteran away from stressful situations
- Getting help when necessary
- Waking the veteran from night terrors
- Interrupting the veteran's panic attacks
- "Clearing" a room or apartment
- Maintaining a veteran's personal space

I started Tate's training in February. Everything that I asked, he was willing to do and learn. PAD dogs are trained in basic obedience, but we also do so much more. For example, I will fake panic attacks and night terrors to teach him to comfort and help get the Veteran out of that moment. Most of the dogs that are in the program are rescues or have come from shelters. This is a program that not only is there for Veterans but also helps out dogs.

A pleasure to work with and foster, Tate comes to work with me, to get groceries, church, movies, etc. Everywhere. Wherever we go, he is well loved. Tate has a very natural instinct to help. He is one of a kind.

I have professional pictures taken of every dog that I have trained from start to finish I then have some pictures printed to give to the Veteran with whom the dog is matched and also write a background of where the dog came from.

Tate will soon be meeting with Veterans and will be doing exactly what he was meant to do.

An Opportunity to Support Military Dogs

Club Member Ginny Altman would like club members to be aware that working military dogs, GSD or otherwise, need our help.

"A news article was in the paper on July 16, 2015 relating the information about our 2,000 military dogs. Many of these are outside of the country and when their tour of duty is done they are not brought back home. A bill has been introduced to Congress to support that **no canine comrade is left behind** and that the military would transport the dogs home where they would be offered for adoption, first to the military dog handlers. The animals may also help their handlers adjust to civilian life and combat post-traumatic stress disorder."

Amy Marotz and Kolachi, “renaissance dog”

This issue's Member Spotlight features GSDCMSP member Amy Marotz, who lives with her husband, Dave, and kids, Alex and Justin--and, of course, her GSD Kolachi--in Woodbury.

How did you become interested in dogs?

Prior to owning Kolachi, I rescued a 6 year old basset hound, Copper. We obtained her CGC and TDI certification, and she taught with me in my middle school English classroom every day for three years! When she passed, it took quite a while for me to be ready for another dog. Copper was my best buddy, and she taught me so much.

How did Kolachi come to join your family?

My husband, Dave, and I had a deal. If he was accepted to business school, I could add a puppy to the family. We decided that a German Shepherd would be the best fit for our young family's needs- devoted, protective, athletic, intelligent!

After a disheartening preliminary internet search, resulting in finding a plethora of sketchy backyard breeder websites, I searched the GSD Forum page as due diligence fact-checking exercise on another breeder. As I scrolled through the pages, RiverRock Kennels and Zoa Rockenstein came up as a responsible, serious breeder. After visiting with her and her dogs a few times, we decided that it was a perfect match. We decided upon a companion girl, with the right temperament for therapy dog work, as I wanted to get back to volunteering with a dog in the future. RiverRock's Black Velvet, "Kolachi" is out of RiverRock's Karla von Kenlyn TC PT OFA H/E, "Karla" and the amazing 2X Sel Ex Ch Anne Isle's Promise Keeper OFA H/E GSDCA Health Aware of Merit, "Tucker". We couldn't be more pleased with the combination!

What is Kolachi's role in your family?

Kolachi is a very sweet and gentle girl. She is constantly watching out for her "kids"- Alexandra (7) and Justin (4). As we homeschool, we all spend a lot of quality time together, and the kids have learned to become strong leaders for her as well. Kolachi has a rock-solid temperament that will hopefully lead us straight to therapy dog work after my human kids get a bit older. Kolachi has a willingness to work that I admire. Despite being a highly intelligent and active girl, she definitely has learned to use her "off switch", which has made her into an ideal house dog and companion.

What are some of the activities you enjoy with Kolachi?

We've had a blast exploring the different dog sports available. Currently we are enrolled in herding, agility and obedience lessons. I'd love to start trialing her soon. We've dabbled in conformation (just for fun), nosework, tracking, dog-powered sports (Justin LOVES getting sled rides from Kolachi), and canicross. On July 25 at the GSDMSP Fun Day, Kolachi passed her temperament testing and received her CGC and TDI (therapy dog) certifications! If you can do it with a dog, I'm up for the challenge! We love camping, and she's proven herself an adaptable and confident girl in any new surrounding. Agility training has paid off very well, as she is able to easily gain her footing on tricky ground (like a canoe or a raft!). Kolachi is a well-mannered, respectful girl, but not a 'robot dog'. She has her own mind and often solves problems before the rest of us know anything is amiss!

We love to travel with Kolachi. I do a lot of VRBO (Vacation Rental By Owner) rentals online, which allow me to find properties with owners who are pet-friendly. Traveling with our (largish) dog does make things interesting- on our trip out to the Black Hills, we ended up stopping at some restaurants and sites that we've never seen before, just because they advertised on the internet as 'pet friendly'! Kolachi got to pose in front of one of Elvis' motorcycles as well as ride on a mule-drawn wagon during that trip! We also invested in a remote car-starter to keep the a/c on full-blast while the family eats in non-dog-friendly restaurants. We definitely have gotten good use out of that! Kolachi has also gone with us to the Gunflint Lodge (on the Gunflint Trail in Northern MN), which is a fabulous dog-friendly north woods retreat where we canicrossed and canoed. We just returned from a lake/boat vacation on the Lake of the Ozarks in Missouri. While she enjoys the wind in her face that a boat ride entails, she has yet to be convinced that swimming is a worthwhile pastime. This coming January, she's going on her first beach vacation to Florida. Maybe paws in the ocean will persuade her that running in the waves is fun!

Tell us about your business.

Beloved Buddy Memory Quilts started after my dear Copper passed. She worked with me in my classroom every day, and our students came to expect that her outfit (a bandanna) would coordinate with mine each day. I remember trying to clean out her cupboard, but not being able to physically part with those dear slips of fabric. Then it came to me—I could make a quilt that would remind me of her every day. I did, and the response from my family and friends was amazing. I was commissioned to do three more quilts before I decided to open an Etsy storefront and offer this service to everyone who was mourning a pet. It's a more tactile and visual way of memorializing a friend than just having an urn sitting on a shelf somewhere. I can work in collars, charms, t-shirts, ribbons—into a quilted portrait. Kolachi rests on the floor of my in-house studio while I work. She has absolutely earned the title of "beloved buddy" that started with Copper the basset. How to Serve as a Dog Show Steward

An excellent opportunity to get involved in the show scene

You have been talked into stewarding at your specialty show, with the words "its easy." Not to worry--anything is easy when you know how.

The steward keeps everything in the ring running smoothly. You are the judge's right hand person. You also are the person exhibitors check in with. A good steward arrives an hour before the scheduled judging start time. First of all, walk the ring, checking for anything that could cause a dog or exhibitor a problem.

Check for uneven ground, holes or low spots. Pick up any pieces of trash. In the mid to late summer, check for ground bees. Exhibitors or dogs should not be in the ring if bees are present. Exhibitors should not be in the ring for any reason before the start of judging.

Next, on the judge's table, you are responsible for anything the judge might need. First of all is the judge's book. This should be prepared by the show secretary. It is best if it is in a covered holder as protection from rain and wind. Also include pens. **Under no circumstances should anyone but the judge mark in this book.**

Armbands should be on the table in the order they are listed in the catalog. Also, you will need rubber bands for the armbands. You will need 3 show catalogs--2 for the stewards, and one to give to the judge after judging. Never should a show catalog be left open where a judge can see it.

Other items necessary at the table are a copy of "The Rules and Regulations for Dog Shows," and "The AKC Breed Standard." Additionally, it is helpful to have a first aid kit, wet wipes, paper towels, Kleenex, sun screen, tape of some sort, rain gear and a hat.

If an exhibitor identifies an error in his or her entry in the catalog, find the chief

ring steward. If you are the chief ring steward (find out before the show), you should have available any AKC paper work covering this situation. If any number is incorrect in the judge's book, let her know so she can make the change. Remember, you do not write in the judge's book.

When the judge arrives, introduce yourself and ask for any instructions she has such as how to line the dogs up (catalog order or not) and how she wants to handle absentees or anyone arriving late. Ask her if there is anything else she would like such as water, coffee, soft drink, etc.

Remember when calling the dogs to the ring, never say the dog's name or the handler's name. Only call the numbers. Your own dogs should never be shown under a judge for whom you are stewarding. When the judge is placing a class, you should have the next class in the ready ring prepared to enter the ring.

As soon as the judge has placed the class, bring the judge's book and pen to her. As she is marking her placings, you should also be marking your catalog. As soon as the judge has finished her markings, take the book, and hand her the ribbons in order, as well trophies, if any. Remember, only the judge can hand out ribbons. At this point it is helpful to have 2 ring stewards because the next class should already be in the ring.

Check to see that the judge's book matches yours. If not, notify the judge before going any further.

Make sure you or someone takes the judge to lunch or dinner. Also have a check ready for her. Be neat in appearance. Do not argue with the exhibitors. Be courteous at all times. Have fun!
